Studio Policies, Tuition & Attendance

Tuition & Billing

Tuition is billed on the 1st of each month. All payments are non-refundable and non-transferable. **A card on file is the preferred method of payment for monthly tuition.** By enrolling, you authorize Temple Dance Center to charge the card on file for monthly tuition and any applicable fees. **If a card is on file, a \$25 late fee is applied to accounts not paid by the 5th of the month.**

If paying by cash or check, **a \$30 late fee will be applied to accounts not paid by the 5th day of the month.** Accounts unpaid by the 10th may result in suspension of class participation. Withdrawal requires written 30-day notice via email prior to the next billing cycle.

Class Cancellations & Drop-Ins

Students must cancel a class at least 12 hours before the scheduled start time to retain their class credit. Drop-in no-shows or late cancellations forfeit the class fee or credit.

Late Arrival & Warm-Up Policy

For safety and injury-prevention purposes, all students are strongly encouraged to arrive on time and participate fully in the class warm-up. **If a student arrives after the warm-up has been completed, they may still join the class; however, they do so at their own risk.** By participating without completing the warm-up, the student acknowledges that they may be at increased risk of injury and agrees that Temple Dance Center and its instructors are not responsible for any injuries that may occur as a result of late arrival.

Liability Waiver & Assumption of Risk

Dance training involves physical activity that may include stretching, strength work, cardio movement, floor work, and choreography. These activities carry inherent risks, including but not limited to muscle strains, sprains, fractures, falls, and concussions. By signing below, the participant (or parent/guardian) voluntarily assumes all risks associated with participation in classes, rehearsals, performances, and studio activities.

The participant releases Temple Dance Center, its owners, instructors, staff, and affiliates from any and all liability for injuries, damages, or losses sustained during participation, including those arising from the ordinary negligence (active or passive) of the studio or its staff, to the fullest extent permitted by New York State law.

Medical Consent

In the event of an emergency, the participant authorizes Temple Dance Center staff to obtain medical treatment and/or emergency transport at the participant's expense. The studio is not responsible for medical costs incurred as a result of injury.

Media Release

The participant grants Temple Dance Center permission to photograph or record classes, rehearsals, and events, and to use such media for promotional, educational, or commercial purposes without compensation.
